The Sliding Scale

Note that your FPL bracket is determined based on your Gross Family Income and Family Size; remember to consult the link above if you're struggling to identify your bracket.

FPL Income Bracket*	Fee Reduced By:	Adjusted Fee Per 30 Minutes:
0 - 150% FPL	60%	\$60.00
151 - 200% FPL	50%	\$75.00
201 - 300% FPL	35%	\$97.50
301 - 400% FPL	15%	\$127.50

400% and above FPL does not qualify for sliding-scale adjustment, however, we do offer payment plans.

Additional services, like DNA Ally Fees may be waived for those under 200% FPL.

FINANCIAL ASSISTANCE

WHAT IF I'M NOT ELIGIBLE?

Patients in clear need of genetic counseling services who lack health insurance, employment, or are refugees, or experiencing extenuating circumstances resulting in a dire lack of healthcare resources may be eligible for additional financial support or as approved by Clover Genetics. Payment Options

INSURANCE

Many insurance companies offer coverage for genetic counseling and testing. While we do not accept insurance, you can request documentation to process an out-of-network claim with your insurance company in order to make an attempt requesting reimbursement. Unfortunately, Medicaid and Medicare are not eligible for use or reimbursement for most genetic counseling services.

SELF PAY OUT OF POCKET (OOP)

All appointments are scheduled for 1 hour and billed at \$150 per 30 minutes, utilizing CPT code 96040, totaling \$300 for a 45-60 minute visit. Appointments may be shorter than the allotted time, but charges will not be prorated and is based on the amount of 30 minute increments used. Time used in the visit is at the discretion of the genetic counselor. Any additional time will be billed at the same rate of \$150 per 30 minutes. Please reference our current pricing sheet on our website for more information. Payment plans are available for those who are unable to pay the entire cost at the time of service.

HSA OR FSA

Our genetic counseling and testing services qualify for payment via an HSA (Health Savings Account) or FSA (Flexible Spending Account).
